8. The 60 month parts and labour guarantee is as stated and no cash or other alternatives shall be available.
9. By purchasing a Selected Appliance and obtaining the 60 month labour and parts guarantee, you agree that the Promoter will disclose your data to Domestic and General Group Limited ("D&G") for the administration purposes only of this promotion. Your data will not be used by the Promoter or D&G for marketing purposes unless your consent has been obtained separately.

The Promoter reserves the right to refuse to honour the extended labour guarantee if it has reasonable grounds to believe that the consumer has breached any of the terms and conditions or has been fraudulent or has acted contrary to the spirit of the promotion. By purchasing a Selected Appliance, you confirm to be bound by these terms and conditions.
11. You understand that all information (including these rules) relating to this promotion published on any promotional or advertising material or on any website at any time before or during the Promotional Period will form part of the terms and conditions of entry.
